**Biography**

Edwin C. Goddard was born in 1865 in Winnebago, Illinois. From 1895-1900 he served as a professor of mathematics at the University of Michigan, where he received his bachelor of law in 1899. Following this, he served as a professor of law until his retirement in 1935. Goddard was an active member of the Ann Arbor community, and served at various points in time on the Board of Education, park board, community fund, and city selective service board. Goddard died in 1942.

**Collection Scope and Content Note**

It is not known when, or if, Goddard traveled to the Philippines. One object tag indicates that a particular object was “sent to Professor Goddard by friends in 1900.”

The collection has not been attributed to any Philippine ethnolinguistic groups. The collection has also not been reviewed by an individual with expertise in Philippine ethnolinguistic cultures. The catalog information reflects what has been previously provided by the donor and the Museum’s historic naming conventions. At this time, it cannot be stated with specificity when, where, or by whom the objects were created.
